RTA is in the process to reverse excess 1064 shares to IEPF account. Please note that shares have not been transferred in actual, however as the same file was uploaded twice on NSDL, the record shows credit to IEPF account twice for 1064 shares. We have already submitted our application with NSDL and IEPF Authority to reverse the excess 1064 shares.</p>
